#### Explanation of Fees

- \* If a swimmer cannot continue for the entire season, coaching fees for the remaining period must be paid and will not be refunded.
- \* To be eligible to participate in scheduled practices beginning September 12, 2012, account balances must be paid in full. If payment is an issue, please contact Lebanon Swim Club President, Chuck Goff.
- \* For swimmers to be eligible for meet and practice participation throughout the season, their account must not be more than 60 days past due - no exceptions. If payment is an issue, please contact Lebanon Swim Club President, Chuck Goff.
- \* The USA Swimming fee includes a subscription to Splash magazine, excess accident and liability insurance, and an opportunity to participate in USA Swimming sanctioned meets.
- \* The Administration fee is used for administrative costs of the club including printing, website maintenance, supplies, etc.
- \* The Splash Fund is your "escrow" account used to pay meet fees. The member will not be entered into a meet should there be insufficient funds to cover their entry. The board and coaches will work to ensure account levels are communicated regularly to avoid potential issues with an entry.
- \* The member is responsible for the difference in coaching fees (if any) when moving to a new group.
- \* Payment can be made:
  1. Placing the payment in the payment box near the family folders
  2. In person by giving the payment to the treasurer
